Preschool Development Grant Birth through Five (PDG B-5) Competition

PDG B-5 2018 Grant Competition

PDG B-5 Competition

The Departments of Health and Human Services and Education (collectively, the Departments) are holding a competition for:

Preschool Development Grant Birth through Five (PDG B-5) Initiative, CFDA Number 93.434





Purposes of the PDG B-5 Initiative

- Develop, update, or implement a strategic plan that facilitates collaboration and coordination among existing programs of early childhood care and education in a mixed delivery system across the State;
- More efficiently use existing Federal, State, local, and non-governmental resources to align and strengthen the delivery of existing programs;

Purposes of the PDG B-5 Initiative

(continued)

- Encourage partnerships among the wide range of ECE programs and service partners that make up the B-5 Early Childhood State System;
- Expand parental choice and knowledge about existing programs; and
- Enhance school readiness for children from lowincome and disadvantaged families, including during children's transition into elementary school by sharing best practices between and among ECE providers.

Five Required Activities

- Activity One: Conduct or update a thorough statewide birth through five needs assessment of the availability and quality of existing programs/services in the State.
- Activity Two: Develop or update a strategic plan, based on needs assessment results, that recommends collaboration, coordination, and quality improvement activities among existing programs.
- Activity Three: Maximize parental choice and knowledge; promote and increase involvement by parents and family members in the development and transition of their children.

Five Required Activities

(continued)

- Activity Four: Share best practices among early childhood care and education program providers in the State to increase collaboration and efficiency of services, including to improve transitions from such programs to elementary school.
- Activity Five: After activities one and two are completed, improve the overall quality of early childhood care and education programs in the State.
- Additional emphasis on data (integrating systems) and evaluation.

<u>Note</u>: Work on Activities Three and Four can begin at the start of the grant period.

Award Information

- Award Floor = \$500,000
- Award Ceiling = $\frac{15,000,000*}{15,000,000*}$
- Match Requirement = minimum of 30%
- Project Period = 12 months*
- *Specific to funding for Activity Five, States must seek funding appropriate to the anticipated grant time remaining after the statewide birth through five needs assessment and related strategic plan that meet the descriptions and requirements in this FOA have been completed, submitted, and approved by the Departments.
- *States awarded initial grant funding will be eligible to apply for renewal funding for years 2-4.

Initial vs. Renewal

Initial Grant = Improving the Existing System

- Needs assessment
- Strategic planning
- Making the existing system easier to navigate for families
- Addressing gaps related to transitioning from one part of the system to another, and particularly to elementary school
- No creation or expansion of services to children

Renewal Grant = Implementing the State B-5 Strategic Plan

Readiness Assessment Legislation

- Read to Succeed Act (Act 284) Section 59-155-150(A) in 2013-14
 - Every student enters PreK and 5K beginning in FY 2014-15 to be administered a readiness assessment with initial focus on language & literacy
 - Beginning in FY 2016-17, assessment must also assess mathematical thinking, physical well-being and social-emotional development.
 - Status Check: Not all 4K assessments include additional domains



Readiness Assessment Legislation

- First Steps Reauthorization (Act 152) Section 59-152-33(A)(2) in 2017-18
 - First Steps Board shall use the results to assist county partnerships to support local initiatives to improve readiness for all students





What is **Reported as** Part of the Indicator but **NOT** factored into the Rating

For Elem Schools:

1. Number and percentage of students entering Kindergarten ready to learn 2. Percentage of 2nd graders on track for 3rd grade

success in Reading and Math

For High Schools:

1. The percentage of students passing Civics Test



Goal of the KRA:

 Provide information on children's preparedness for kindergarten

Assessment:

- Given within first 45 days of kindergarten school year
- Census
- Items are multiple choice and performance assessment

Description of KRA

- 60 items
- Administered by trained raters to each child
 - Time: approx. 40 minutes per child

KRA Subscales

Subscales assessed:

Language and Literacy: reading, writing, speaking, and listening

Mathematics: counting, comparison, and sorting

Physical Well-Being & Motor Development: dexterity, muscular coordination, and balance

Social Foundations: demonstration skills necessary to the functioning within the kindergarten classroom

Scoring the KRA Subscale and Total scores

Demonstrating Readiness: Student *demonstrates* foundational skills and behaviors that prepare him or her for instruction based on kindergarten standards.

Approaching Readiness: Student *demonstrates some* foundational skills and behaviors that prepare him or her for instruction based on kindergarten standards.

Emerging Readiness: Student *demonstrates limited* foundational skills and behaviors that prepare him or her for instruction based on kindergarten standards.



Kindergarten Readiness Assessments


- Nationwide, 37 states require Kindergarten Readiness Tests
 - What is used varies by states:
 - Teaching Strategies GOLD
 - Specific domains (e.g., literacy only)
 - State specific tests
 - KRA used in 5 states
 - Statewide: SC, OH & MD (as well as optional for TN, MI)



KRA Test Results in SC

- First administration BOY 2017-18 school year:
- KRA administered to 54,863 kindergartners across South Carolina.
- Statewide:
 - Approx. 36% of the children were at the KRA Demonstrating Readiness level.
 - 31% of kindergarteners reached Demonstrating Readiness in mathematics (lowest percent at the Demonstrating Readiness)
 - 48% of students at the Demonstrating Readiness level in the Physical Development and Well-Being (highest scoring domain)




Percentage of Kindergarteners Demonstrating Readiness By Race/Ethnicity

District comparisons


- 33 districts met or surpassed the overall state average for Demonstrating Readiness
- 13 districts met or surpassed the state average on every KRA domain:
 - Anderson 4, Charleston, Clarendon 1, Dillon 3, Dorchester 2, Fairfield, Georgetown, Greenwood 52, McCormick, Richland 2, SC Public Charter School District, York 2 and York 4.

Using KRA Results: MD/OH

How are states using results?

At the PK level:

- Create policy
- Funding priorities
- Program Improvements

At Kindergarten level:

- Shape classroom instruction
- Direct Individual student learning



Using KRA Results: SC

How should SC use results?

- First Steps to develop a **long-range initiative** for increasing school readiness (59-152-32)
- **Results** of screenings and developmental intervention must be **provided in** writing to parent or guardian (59-152-33)
- District reading plan must incorporate activities for children whose oral language and emerging literacy skills are below national standards (59-152-33)
- State Board of Education must adopt a system for reporting populationlevel results with baseline data for measuring overall student change over time (59-152-33)
- First Steps must provide professional development supporting readiness assessment for teachers and parents supported with First Steps Funds (59-152-33) and
- Local First Steps Partnership Boards must improve readiness of young children for school (59-152-60, 59-152,70 and 59-152-100)



KRA Recommendations/Next Steps

 If SC improved annual percentage of children entering kindergarten ready to learn by 3% annually (or 1,650 children per year) all children would enter kindergarten ready by 2037.

2022	51%	28,050
2027	66%	36,300
2032	81%	44,550
2037	96%	52,800



KRA Recommendations/Next Steps

- Backing Up:
 - How will we as a State, move young children forward?
 - What percentage of our kindergartners should be ready to learn and by when?
 - What is the comprehensive long-range initiative for increasing school readiness in SC? How does the initiative address the needs of the whole child?
 - How will you, as a leader in your county, help children take the next step?
- Looking Forward: Roughly 30-40% of students graduate high school college and career ready

Free Four-Year-Old Kindergarten! 2018-2019 School Year, Aiken County

In order to qualify for the program, the Child must:

- Be 4 years old ON or BEFORE September 1, 2018
- Be eligible for Medicaid or the free/reduced-price lunch program.
- Live in one of the 64 qualifying school districts.

Current Participating Centers in Aiken County:

Centers may choose an option Of 180 days or 220 days at 6.5 hours or 8 hours each day.

- 213 centers approved
- 29 new centers adding 484 new slots
- 234 4K classrooms
- 3750 total 4K slots
- 1429 students currently enrolled with 100 applications in process
