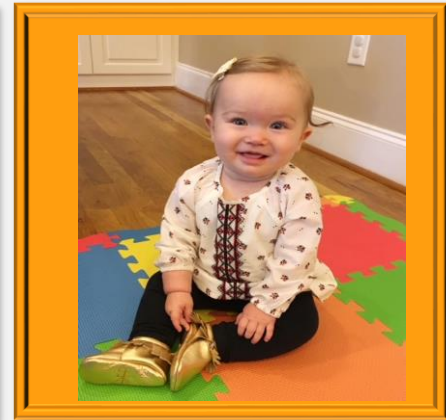

# Executive Director's Report

## 2020 State Budget Request

- \$5,000,000 - **Early Childhood Innovation Grants:** Tax Credit to fund competitive grants to local partnerships that incentivize and support measurable outcomes, leveraging of resources, program expansion and program enhancement.
- \$737,448 - **Data and outcomes-tracking system** to meet the requirements described in statutes. One time cost to purchase system (\$595,000) plus recurring costs of one FTE to manage and monitor, and for licenses and maintenance (\$142,448).
- \$105,000 - **State Office Information Resource Coordinator** to provide management and oversight of Information Technology needs.

# Executive Director's Report

## Grant Opportunities

### **AmeriCorps**

- AmeriCorps member would provide direct service
- Local Partnership would be AmeriCorps Grantee with State Office providing co-funding

### **School Improvement Council - Carolina Family Engagement Center**

- First Steps will receive \$10,000 in year 1 funding for:
  - Printing and distribution of the Profile of the Ready Kindergartener Brochure
  - Stipends to support Local Partnerships in integrating their early childhood-focused boards with the community infrastructures the SIC Grant will be developing with this funding to ensure smooth transitions for children across all stages of their schooling
- First Steps will provide some match through existing CTK programs

# Executive Director's Report

## Local Partnership Grant Opportunity

### **Early Childhood Innovation Grants:**

Competitive grants that incentivize and support measurable outcomes, leveraging of resources, program expansion and program enhancement. The intent of the grants are to reward outstanding performance of existing programs and services.

- Total funding available for competition: \$100,000 (state and private funds)
- Minimum grant award amount: \$10,000
- Partnership must be in good standing
- Goal: award grants at State Board Annual Meeting, December 6, 2018

### **Proposed Application Elements:**

- Timeline for implementation
- Detailed budget – include in budget narrative components that can be prioritized so that grant reviewers can consider partial funding if necessary
- Evaluation Plan – including outputs and outcomes
- Link to Partnership Comprehensive Plan's identified goals

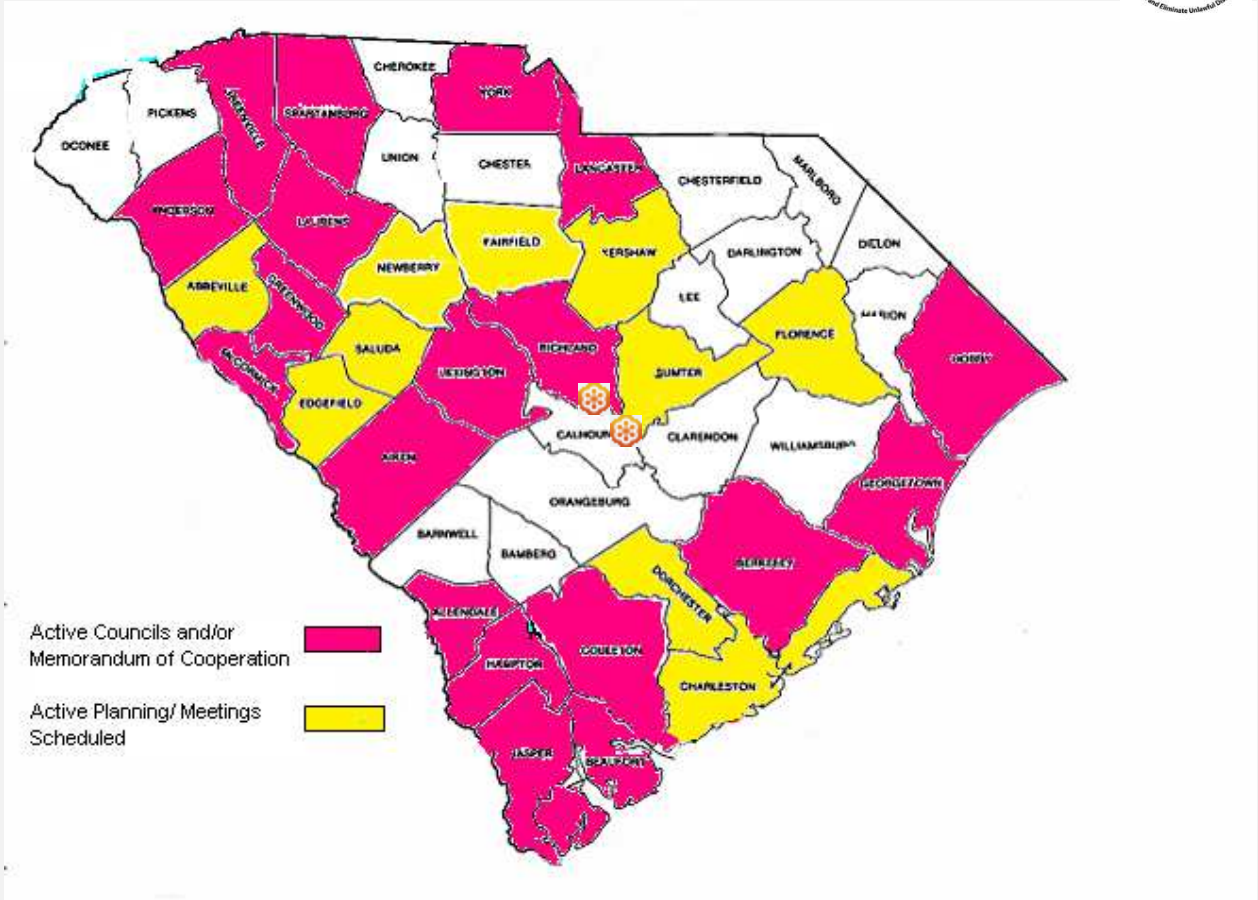


# Community Relations Councils



- Established throughout the state at local community levels to resolve problems locally
- Mission of Human Affairs Commission is to work through these councils to carry out its mandate to improve relationships among the citizens of South Carolina
- Counties considered geographical boundaries for operation of local councils
- 18 existing councils state wide
- Focus is “Quality of Life” issues

# PDG B-5 Competition

The Departments of Health and Human Services and Education (collectively, the Departments) are holding a competition for:

**Preschool Development Grant Birth through Five**

(PDG B-5) Initiative, CFDA Number 93.434



# Purposes of the PDG B-5 Initiative

- **Develop, update, or implement a strategic plan** that facilitates collaboration and coordination among existing programs of early childhood care and education in a mixed delivery system across the State;
- More efficiently use existing Federal, State, local, and non-governmental resources to **align and strengthen the delivery of existing programs;**

# Purposes of the PDG B-5 Initiative

(continued)

- **Encourage partnerships** among the wide range of ECE programs and service partners that make up the B-5 Early Childhood State System;
- **Expand parental choice and knowledge** about existing programs; and
- Enhance school readiness for children from low-income and disadvantaged families, including during children's **transition into elementary school** by **sharing best practices** between and among ECE providers.

# Five Required Activities

- *Activity One:* Conduct or update a thorough statewide birth through five needs assessment of the availability and quality of existing programs/services in the State.
- *Activity Two:* Develop or update a strategic plan, based on needs assessment results, that recommends collaboration, coordination, and quality improvement activities among existing programs.
- *Activity Three:* Maximize parental choice and knowledge; promote and increase involvement by parents and family members in the development and transition of their children.

# Five Required Activities

(continued)

- *Activity Four:* Share best practices among early childhood care and education program providers in the State to increase collaboration and efficiency of services, including to improve transitions from such programs to elementary school.
- *Activity Five:* **After activities one and two are completed,** improve the overall quality of early childhood care and education programs in the State.
- Additional emphasis on data (integrating systems) and evaluation.

Note: Work on Activities Three and Four can begin at the start of the grant period.

# Award Information

- Extended deadline for NC/SC: November 20
- Award Floor = \$500,000
- Award Ceiling = \$15,000,000\*
- Match Requirement = minimum of 30%
- Project Period = 12 months\*
- \*Specific to funding for Activity Five, States must seek funding appropriate to the anticipated grant time remaining after the statewide birth through five needs assessment and related strategic plan that meet the descriptions and requirements in this FOA have been completed, submitted, and approved by the Departments.
- **\*States awarded initial grant funding will be eligible to apply for renewal funding for years 2-4.**



# Initial vs. Renewal Grant

## Initial Grant = Improving the Existing System

- Needs assessment
- Strategic planning
- Making the existing system easier to navigate for families
- Addressing gaps related to transitioning from one part of the system to another, and particularly to elementary school
- No creation or expansion of services to children in Year 1

## Renewal Grant = Implementing the State B-5 Strategic Plan

- Potential for funding Yrs 2-4

# Finance Update

## **Carry Forward Policy**

- Carry forward should be added to your budget spending plan through a budget reallocation before December 14, 2018.
- If the use of carry forward was not approved during the Renewal Plan Process, your board must approve use of carry forward funds.
- If carry forward funds are being used to begin a new program that was not included in your FY19 Renewal Plan, you must first seek approval from the State Board Program and Grants Committee (next meeting will be November 28, 2019).

# Finance Update

## **Process for Verifying Staffing Time Study results with Budget Spending Plan Cost Allocation**

- Once period for time sheet study is complete – send time sheets along with summary analysis to Finance Office
- If time sheet %'s are in line with BSP cost allocation %'s, then no further documentation is necessary
- If time sheet %'s do not reflect BSP cost allocation %'s, then BSP must be adjusted to reflect proper time allocated to each program based on actual time sheets. Finance office will assist you in making the appropriate adjustments

# Data System Update

## **New/recent changes:**

- Program Supervisor login
- New consent form available English and Spanish
- Race/ethnicity for clients, program staff, child care staff
  - data entry question
- CLASS assessment available
- Well-child visit available
- Updated staff trainings and certifications



# Data System Update

## **NEW: Program Supervisor login**

- Allows program supervisors to view and enter data for all vendor logins within the same program code (great for PAT supervisors with multiple staff)
- Program supervisors may delete members of a case record (but not the entire case)
- How to obtain a program supervisor login: request in the usual way using the FY19 Data Use Agreement form located on the FSDC web site. There is a new Program Supervisor category on the form.

# Data System Update

## **Race/ethnicity changes:**

The race/ethnicity data fields are being changed to match PowerSchool for clients and staff.

- Instead of a drop down, there will be individual Race check boxes for:
  - RaceA (Asian),
  - RaceB (Black or African American),
  - RaceI (American Indian or Alaska Native),
  - RaceP (Native Hawaiian or Other Pacific Islander),
  - RaceW (White),
  - and one check box for Hispanic ethnicity.
- Multiple race check boxes will be able to be checked.
- Timeline: soon ... (this week for clients)
- Current data will transfer EXCEPT: Hispanic clients will have no race entered, and data will need to be entered for clients who identify as multiple races

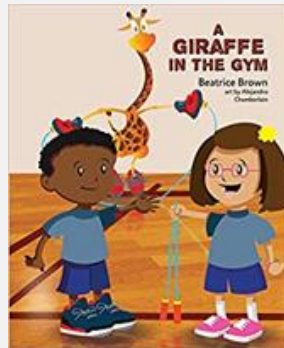
