### 1. Parent Engagement

Provide opportunities for parents and caregivers to develop a positive attitude toward further understanding of their child's healthy development.

Promote learning in an environment that acknowledges children's diverse backgrounds and supports them in a successful transition from early childhood programs to school.

Provide early intervention screenings and assessments for babies and toddlers to identify and evaluate as early as possible if a child's healthy development is compromised and connect the family with the appropriate intervention services to improve child and family development.

Build resilience within children and families, improve child safety, and intervene to mitigate the harms of adverse childhood experiences.

- By the end of 2026, we will increase well-child visits, immunizations, and oral health recommendations by 10%

## Overarching Measure(s) of Success

### **INCREASE THE REACH OF FIRST STEPS SERVICES**

By FY26, the percentage of children in need who are directly served by Orangeburg County First Steps will increase from 5% to 7%.

## INCREASE THE PERCENTAGE OF INCOMING KINDERGARTNERS WHO ARE READY FOR SCHOOL

By 2026, the percentage of children who score at the highest level on the Kindergarten Readiness Assessment will increase by 2% each year to 31%.
