

During Fiscal Year (FY) 2024, Lee County First Steps (LCFS) continued to experience the opportunity to be even more committed to providing programs, services, and support to the children and families in Lee County and other areas by being focused and driven to meet our overarching goal to ensure that children arrive at school healthy and ready to learn. With the vision, commitment, and fortitude of the LCFS Board Members, I have been committed to ensure that our partnership is strategic and focused-driven with developing strong sustainable, collaborative partnerships that impacts Lee County, our region, state, and nation in a progressive manner. I have been committed to enhancing and strengthening our community's ability to meet and reach the goals of our comprehensive plan. In fact, we have been able to expand our Save the Children Early Steps Program with funds from SC First Steps ESSER Parenting Competitive Grant Funds, and READY Grant Funds Award. During FY2024, LCFS has had the privilege to be one of three Local Partnerships to be the

recipients of a muti-year \$200,000 SC First Steps Carolina Collaborative for Innovation Grant which will allow us to assess the implementation of parenting programs and school transition through the lens of a "Theory of Change." Also, LCFS has been able to expand the Strengthening Family Programs in Lee, Florence, Sumter, Williamsburg, and Darlington Counties. Also, Lee County First Steps is in the final year of the SC First Steps ESSER-3 Parenting Grant which provided the opportunity for expansion of parenting programs and child care services in Lee County. Also, Save the Children continued to provide support for LCFS to host a local Parenting, Family, and Community Summit, and the 2024 Early Childhood Summit Gala. Also, LCFS was able to continue implementation of Family Café the Be Strong Parent Café Model. LCFS has received the opportunity to participate in a five-year project that will yield \$100,000 to the local partnership from Morehouse School of Medicine Project Impact, which will test the implementation of preconception counseling in community-based settings to improve cardiovascular health outcomes before and during pregnancy in order to improve maternal health outcomes among black women.

Our leadership has solidified our long-standing collaboration with SC First Steps, Lee County School District, Children's Trust of SC, Save the Children, Bishopville-Lee Child Development, Wateree Head Start-Bishopville Site, Kiddie Land Family Day Care, Darlington-Lee County Adult Education, and now Morehouse School of Medicine. I am grateful for having an awesome team-LEE TEAM, our employees, consultants, contractors, AmeriCorps Members, collaborating partners, and volunteers who have been consistent with their work ethic to help us meet the needs of our children and families in such a dedicated manner. LEE TEAM's work ethic and commitment is intricately weaved throughout this FY 2024 Annual Report I would also like to salute all of the children, parents, grandparents, caregivers, Early Childhood Staff that have been enrolled in our programs and allowed us to be part of their families' life in such a meaningful manner.


