Priorities: Summary

1. According to our Needs Assessment, the federal poverty level (<185 percent), equaling 43% under age 6 in Anderson County (year 2020), is a priority area.

Our county's zip codes with demonstrated needs are 29624, 29625, and 29631. As of 2020, Anderson County had a total birth count of 2152, with a 991 expected Medicaid birth count. The number of babies having less than adequate prenatal care was 353.

2. Low Maternal Education (less than high school graduation) is a priority.

Of the total live births in 2020, with mothers having less than a high school diploma, there were 322 total live births, (202 white, 72 African American, 45 Hispanic, 3 Other).

3. Kindergarten Readiness Assessment (KRA) scores are a priority area in Anderson County, with 32% ready in 2021.

The KRA provides a snapshot of students' abilities at the beginning of the school year. It measures a child's school readiness across multiple domains: Social foundations, language/literacy, mathematics, and physical well-being.


Anderson County – Population Under Age 6 < 185% FPL (Percent)



Anderson – Kindergarten Ready (Rate) Overall: 0.32 Year: 2021


