January 2023 -March 2023







## **Priority One: Kindergarten Readiness**

# 10% of incoming kindergarteners in Jasper County demonstrate readiness on the KRA, well below the state average of 36%.

The KRA is a developmentally appropriate instrument that measures a child's school readiness across multiple domains: Social Foundations, Language/Literacy, Mathematics, and Physical Well-Being. Understanding a child's school readiness helps kindergarten teachers best meet the child's needs, and it helps schools, families, communities and policy makers know how best to support young children as they enter the K-12 environment. Administered within the first 45 days, the KRA provides a snapshot of students' abilities at the beginning of the school year.



## **Priority Two: Single Parent Households**

## 61% of Live Births in Jasper County are to Single Mothers

Definitions: Percent live births in which marital status on birth certificate is listed as single, including birth certificates indicating a single mother with information on paternity. Marital status indicator on S.C. Birth Certificate:


- 1. Unmarried Mother has never married, or is widowed, or is legally divorced for longer than 280 days.
- 2. Married Mother is married or was married within 280 days following conception.
- 3. Paternity Acknowledgement Father's name is listed on the birth certificate of a child born to an unmarried mother, with written consent of the father and mother as stipulated in SC Code § 44-63-165.



## **Priority Three: Convener and Portal**

## There are more than 50 agencies and organizations providing child and family services in Jasper County

Although there are a plethora of resources to address many needs in our county, they are often underutilized by those who could benefit from the services. There is a need for a more centralized "hub" where clients' needs and agency resources can be coordinated.
