## American Academy of Pediatrics (AAP) – Guidance Related to Childcare During COVID-19

- AAP guidance is based on what is currently known about the transmission and severity of coronavirus disease. The <u>AAP guidance is located here</u>.
- References <u>Caring for Our Children</u>, the National Health and Safety Performance Standards Guidelines for Early Care and Education Programs, and refers back to CDC guidance.
- Includes helpful FAQs (ex., "How should I conduct daily health checks?", "How do I develop a written plan for a pandemic?")

## South Carolina COVID-19 Response

- Without a state mandate, child care providers in SC have determined on their own whether to close to remain open during this time. Emergency licensing plans are in place, including options for exceeding capacity to accommodate displaced children, foster children, or children of DSS staff and first responders.
- As of **4/30/2020, 1,234** child care centers remain closed voluntarily. This is compared to 1,288 centers that had voluntarily chosen to close as of 4/13/2020.

# South Carolina COVID-19 Resources

### SC DSS "Best Practices for Staying Healthy"

- Make sure children, staff, and visitors are washing hands as directed by SC DHEC.
- Clean and disinfect all surfaces within the facility regularly.
- Practice social distancing when possible.
- Consider changing your sign in procedures for parents and other visitors (e.g., move handoffs closer to the front door to minimize parents coming into the classroom space and avoid possible exposure to children and caregivers).
- Limit visitors to the facility.
- The careful handling of your food service to children is important. Please limit communal sharing of food, and donations where possible.

#### Policies, Procedures and Other Considerations as a Program Reopens

#### Prior to the First Day a Child Attends

#### Capacity

- Can you do a soft opening with a few children re-enrolled and then gradually add more children week to week?
- If you are opening at less than full (pre-COVID) enrollment, how will you make reenrollment decisions?
  - Consider age groups, available teaching staff and which classrooms can be open safely while maintaining physical distancing.
  - Consider any state directives to serving "Essential Workers."
- How will you notify families of these decisions?
- What will happen with families whom you are not able to serve right away?
- If less than full (pre-COVID) enrollment, how will you decide when to increase enrollment levels?

#### **Enrollment Related Questions**

• How are you sharing information about updated and/or temporary policies and procedures with families prior to re-enrollment?

What additional precautionary measures might you employ around the enrollment process? For example, online enrollment and bill pay.

# **Other Helpful Resources and Suggestions**

- If you don't have one already, consider establishing a "Director's Network" or hold a few virtual meetings with child care directors in your community to problem-solve and share resources for reopening and operating during the pandemic
- Assist providers in obtaining cleaning supplies needed to reduce virus spread
  - DSS Grant
- Help providers find needed supplies for regular operations (ex., toilet paper, baby wipes, milk, food for snacks, lunch)
  - DSS has partnered with Merchant FoodService to help providers purchase comfortably with pickup locations in Columbia, Newberry and North Charleston: <u>Linked here.</u>
- Consider helping to partner providers with local schools or higher education institutions for supplies

# **Drop Off and Pick Up**

- Similar to car pool lane. Designated staff person(s) to meet parents at cars and take children into center. Parents asked not to get out of car.
- Drop off times between 9-10, pick up between 3:30-4.
- Car seats or strollers will not be left at center.
- If earlier pick up, parents must call center and child will be brought out. Parents will always have access to child, not to building.
- Children's temperatures taken

# **Food**

 To minimize staff touching of food - no microwavable food. Must be in zip lock bag to be thrown away. All food must be cut up. Lunch boxes or plastic containers not allowed, nothing will be sent home.

# **Bottles**

 All bottles must be in zip-lock bag with name. Bags will be sanitized after bottles are used and empty bottles will be sent back home in same bag (to be disposed of by parents).

# <u>Nap-time</u>

 No scheduled nap-times, children will have "quiet time". Children that need a nap will be allowed to nap on a cot. Sheet and blanket is allowed in zip lock bag with child name; items will be laundered daily and not sent home with child.

# Extra Clothes

 Each child needs 3 changes of clothes and underwear in a zip locked bag. If child soils clothes without change, parents will be called to pick up child (not using center's extra clothes). Diapers must be in original packaging or zip lock bags. Each child will have outside shoes and inside shoes (closed toes), inside shoes will stay at the center.

# Classroom/Playground Schedule

 Less classroom centers open. Outside times will be longer. One classroom at a time on the playground. Teachers will only be around their children and in their classrooms.

# **Other Items from Home**

 No other items brought from home will be allowed if they are not necessary or essential (pacifiers and loveys allowed, but will remain at the center to be cleaned and sanitized daily).
