By FY23, the percentage of children in need who are directly served by Hampton County First Steps will increase from 25% to 27%.

Increase childhood immunizations

- By the end of FY21, at least one annual health and safety fair will occur educating families on the importance of immunization.
- By the end of FY23, the number of children not being able to enroll in school due to outdated shot records will be less than 2%.
