Objective # 1: Expand Parent Engagement

STRATEGY 1.1

NURTURING PARENTING

SMART GOAL(S)

- By the end of FY'21, we will increase the families participating in parenting workshops by 20%.
- By the end of FY'21, we will meet with Chester County Department of Social Services two times to enhance referrals for expectant parents, and parents of preschool children enrolled in First Steps programs.
- By the end of FY'23, the AAPI scores of clients will increase by 5%.

STRATEGY 2.1

- By the end of FY '23 we will have implemented 8 parent-child activities based on a topic presented during a Facebook Live presentation.

STRATEGY 3.1

Partner with faith-based organizations and churches to support school readiness.

SMART GOAL(S)

- Each year we will host 2 meetings with Faith Based leaders to share school readiness information.
- By the end of FY '21, age-appropriate books and brochures will have been disseminated to 10 churches in Chester County.
- By the end of FY'23, 5 churches will have posted or promoted a school readiness reminder to read to or engage a preschool child in a literacy science or math activity.
