Message from the Executive Director

Since 1999, our mission has always been to serve the children of Florence County by helping families get resources they need to ensure their child's success in school and in life. As we reflect on the 2020 fiscal year, we would like to celebrate the perseverance of our mission despite a worldwide pandemic.

In the middle of our fiscal year, COVID-19 gave us challenges that were unforeseen, including daycare closings and a staggering number of job losses and unemployment. Despite this, Florence County First Steps (FCFS) continued with our programs and followed every protocol to ensure the safety of staff, daycare providers, families, and children. Providers partnered with us received materials such as touch-free thermometers to monitor the health of children and staff. We continued our Child Care Training programs remotely through Zoom meetings. By the end of the year, we held a total of 9 training sessions which were attended by a grand total of 147 teachers and directors. Our Child Care Scholarship program served 22 children and 10 providers. This program also provided 22 developmental screenings.

Our 4K Program had 294 children enrolled and 14 providers who participated.

Our Parents as Teachers (PAT) program, which also went virtual, served 16 families in the area with 373 total visits. Those visits equal up to over 350 hours! The Parent-Child Home (PCH) Program—in collaboration with Florence School Districts Three, Four, and Five—served 43 families and provided over 2,586 total home visits. Our Raising a Reader (RAR) program distributed 424 books to 106 families and 5 providers. Our Quality Enhancement (QE) program, which works to help providers and daycares be the very best they can be, served 10 providers, with 132 TA visits and helped 385 children.

The 2020 fiscal year showed that FCFS is a part of a resilient community who—even when facing a historic pandemic—strives to help the smallest residents of Florence County. Please know that every dollar invested into FCFS goes back into this community, and your support truly makes a difference.





Overarching Measures of Success

Increase the reach of First Steps services.

By FY 23, the percentage of children in need who are directly served by Florence County First Steps will increase from 25% to 30%.

Increase the number of children enrolled in high intensity programs funded by FCFS.

By FY 23, the percentage of children enrolled in high intensity programs will increase from 6% to 11%.

Increase the availability of high-quality early care and education opportunities offered by First Steps.

By FY 23, the percentage of children under age 6 who benefit from Florence County First Steps quality enhancement and training efforts will increase from 14% to 19%.

- By FY23, FCFS will collaborate with community partners to host a community health fair to distribute FCFS and community partners' informational materials to at least 300 families of children ages birth to 5.

Child Care Quality Enhancement

SMART GOALS

- By FY23, 95% of childcare facilities served will participate in the program for at least 2 years.
- FCFS serves two rural childcare facilities in Quality Enhancement. By FY 23, FCFS will recruit 30% of participating childcare facilities from rural Florence County communities and will retain 10% of those facilities.
- By the end of FY23, at least 75% of participating childcare programs will increase their ERS scores by 5%.
