Avian Jones conducted a roll call.



Mr. Dave Morley allowed Tremika Johnson, Chair of Dorchester County First Steps, to speak during the public comment period.

Mr. Dave Morley called the meeting to order at 2:10 p.m. and requested a motion to adopt the agenda. Dr. Canright provided the motion. Dr. Mathis provided a second and the motion was unanimously approved.

Mr. Morley asked for a motion to approve the revised October 22, 2020 minutes. Sen. Hembree provided the motion. Ms. McConnell provided a second and the motion was unanimously approved.

Mr. Morley reported on the Executive Committee and provided thanks to Sen. Harvey Peeler for the appointment of 2 new board members and for reappointing Jennifer McConnell. He went on to introduce new board members Jesica Mackey, filling the role of Parent of a Young Child, and John Hayes, filling the role of Early Childhood Educator. Mr. Morley announced the resignation of board member Angel Johnson-Brebner and the completion of Julie Hussey's term on the board.

Mr. Morley asked for a motion to approve the 2021 SC First Steps Board of Trustees and Early Childhood Advisory Council meeting dates. Ms. McConnell provided the motion. Dr. Canright provided a second and the motion was unanimously approved.

Mr. Morley asked for a motion to approve the consent agenda as follows:

Consent Agenda: Motions Recommended by Committees (David Morley)

a. Motion for the approval of the Horry County First Steps Partnership Board request to begin a new program, Ready4K!, allocating \$2,910 in state funds towards this program. (Programs and Grants recommends)

Dr. Mathis provided the motion. Dr. Canright provided a second and the motion was unanimously approved.

Mr. Fleming reported on the Finance and Administration Committee noting that they have received verbal confirmation that SC First Steps will be reimbursed the \$4.4 million that was spent on COVID-19 efforts. Mr. Fleming acknowledged that \$10.3 million in new money was requested in the state budget request. He also shared that the lease agreement has expired and the agency concluded the solicitation of bids and was currently in the process of securing a new office space.

Ms. McConnell brought forth the recommendation from the Program and Grants Committee to allow Oconee County First Steps to utilize \$2,000 of FY20 state carryforward funds and \$500 in private funds to begin the Dolly Parton Imagination Library Program for eligible families in Oconee County.

Mr. Morley asked for a motion to accept the recommendation presented by Ms. McConnell. The motion was provided by Dr. Canright, second by Mr. Holt, and was unanimously approved.

Ms. McConnell reported on the Programs and Grants Committee, local partnerships that may not be able to fulfill the 15% match requirements due to COVID-19, the status of competitive grants, and the Racial Equity Institute training that members of the staff and local partnership will be attending.

Ms. McConnell thanked Ms. Hussey for her time and work on the Programs and Grants committee.



Dr. Williams reported on the Strategic Planning and Evaluation Committee, the kickoff of the second round of the Build It Back Better survey, the launch of Listen4Good, and continued partnership with the University of South Carolina's Institute for Families and Society.

Sen. Hembree, Rep. Allison, and Sen. Malloy provided a Legislative update.

Ms. Mjartan provided the Executive Director's report and introduced of 5 new team members. She presented the 2019-2020 Annual Report, encouraged members to continue their support of the agency through donating, and reviewed media coverage of SC First Steps for the 2020 year.

Mr. Morley permitted time for Ms. Mackey and Mr. Hayes to make remarks. He thanked Ms. Hussey for her leadership and service. Ms. Hussey expressed her gratitude.

Mr. Morley asked for a motion to adjourn the meeting. Ms. Newman provided the motion. Dr. Mathis provided a second and the motion was unanimously approved. The meeting was adjourned by Mr. Morley.

The Executive Committee of the Board of Trustees met on January 15, 2021. Minutes of the meeting are attached. No votes were taken.

#### **Board Additions and Transitions**

We are pleased to welcome three new members to our Board of Trustees. Governor Henry McMaster appointed Janie Neeley to fill the role of "Parent of a Young Child." Ms. Neeley is the parent of three children. Her youngest son, Marshall ("Marsh"), is diagnosed with Down Syndrome and attends 4K preschool. She is a former South Carolina public school teacher where most of her experience involved working with struggling readers as a reading specialist and as a school district literacy coach. Janie's combined experiences as a teacher and a parent of three children with very diverse learning needs have led her to develop a passion for creating inclusive learning environments. Janie is a strong advocate for early intervention and disability inclusion.

**Dr. Edward Simmer, MD, MPH, DFAPA,** joins the board as the newly appointed and recently confirmed **Director of the South Carolina Department of Health and Environmental Control (DHEC).** Prior to being confirmed as agency director, Dr. Simmer served over thirty years on active duty in the United States Navy. In his most recent assignment, he served as the first Chief Medical Officer and Deputy Director for the TRICARE Health Plan at the Defense Health Agency in Falls Church, VA. He served as the first Officer-in-Charge of the Defense Health Agency Navy Element, creating the command from 27 formerly separate units and leading over 250 Sailors assigned to DHA worldwide. A native of Ohio, Dr. Simmer received his bachelor of arts degree from Hiram College in 1986, his doctor of medicine degree from the Saint Louis University School of Medicine via the Navy Health Professions Scholarship Program in 1990, and his master of public health degree from the Eastern Virginia Medical School/Old Dominion University Consortium in 2001. He is board certified in general and forensic psychiatry by the American Board of Psychiatry and Neurology. In addition, he is certified in administrative psychiatry by the American Psychiatric Association.

Thomas Clark Phillip joins the board as the Acting Director of the South Carolina Department of Health and Human Services (SCDHHS), having been named to the role by Governor Henry McMaster. Mr. Phillip has served as SCDHHS' Chief Financial Officer and Deputy Director for Finance since joining the agency in 2019. Having worked in healthcare finance for 35 years, Mr. Phillip's experience is uniquely suited to lead SCDHHS through its leadership transition. A graduate of Oklahoma State University and a Certified Public Accountant (CPA), Mr. Phillip has served as the chief financial steward of several public and private healthcare organizations. Mr. Phillip is a resident of Richland County.

During his time as Director of SCDHHS, **Josh Baker** served as an active and contributing member on the boards of SC First Steps and the Early Childhood Advisory Council. We are grateful for the collaboration and interagency partnerships forged under his leadership. Thanks to Mr. Baker for his three plus years of service on the board.



#### **Board-to-Board Regional Meetings**

A series of Board-to-Board Regional Meetings kicked off in December 2020, and will continue throughout 2021, with each region having an opportunity to participate. Ahead of the meetings, board members are surveyed to find out what topics, questions or suggestions they would like to discuss, and the agenda is set based on their replies. Members of the First Steps Local Partnership Boards met together with members of the South Carolina First Steps State Board on December 12, 2020 (Piedmont Region) and February 3, 2021 (Lowcountry Region). The next two Board-to-Board Meetings will be for the Midlands Region and Catawba Region.

#### RE: Finance and Administration Report

The Finance and Administration Committee met via Zoom video conference call on January 20, 2021 to receive updates from staff and to take up action items. Detailed meeting minutes are attached. The committee brings forward two action items, and the following updates.

#### **ACTION:** Approval of the Local Partnership Allocation for State Fiscal Year 2021-22

Mr. Barnes presented the proposed allocation amounts for the Local Partnerships for State Fiscal Year 2021-22. He reminded the committee of the new allocation model that was passed by the Board of Trustees two years ago. He shared the new year's model with updated demographics per the policy. He also mentioned the changes in the number of children 5 or under that are living in families with income less than 185% of poverty and talked about this being the third and final year of the phase in of the model. This year, the Local Partnerships will feel the impact of an additional 50% which will bring the total to 100% of the new allocation. The Committee makes the following Motion:

Motion: To approve the Local Partnership Allocations for State Fiscal Year 2021-22.

#### ACTION: Approval of the Local Partnership Match Waiver Requests for State Fiscal Year 2019-20

Mr. Barnes presented two requests from the Local Partnerships for waivers of the required 15% match requirements. This included Kershaw and Horry County First Steps. He reminded them that these requests were related to the time during the Pandemic. The Program and Grants Committee had discussed and supported giving waivers based on the impact of the Pandemic on the Local Partnerships. The Committee makes the following Motion:

Motion: To approve the Match Waiver Requests for Kershaw and Horry County First Steps for the State Fiscal Year 2019-20.

#### First Steps State Office

#### **Financial Report**

The YTD financial report is attached. The agency's financial position continues to be strong. The 4K Program expenses are down due to the Pandemic. We received an additional \$5 million in funding from the Governors COVID funds. These funds are for extended day and extended year costs and are in addition to the \$4.2 million we have been approved to receive as reimbursement for our COVID



expenses during the pandemic. We do expect a cash balance at the end of the year due to the impacts of the Pandemic, but the amount will depend on continued enrollment over the next few months.

#### State Budget Update

Staff gave an update on the State Budget Request. Staff made a presentation to the House Ways and Means Subcommittee on First Steps budget request for FY 2021-22. It remains at the same level as was submitted to the Governor. The Governor has proposed statewide expansion for the 4K Program in his budget request to the General Assembly which would mean more funds than we requested for SC First Steps, if it passes.

#### Lease Update

Mr. Barnes updated the Committee on the status of our Lease Solicitation process. Staff are working with the appropriate state agencies to select and get approval for a new facility and will most likely be moving into a new facility during the summer of this year.

#### **Local Partnerships**

#### **Update on Raisers Edge**

Progress is continuing with the implementation of the new fundraising software that was purchased with the Blackbaud Financial Edge software. This is the system which replaced the financial management system for the Local Partnerships last year.

#### Local Partnership Financial Audit Update

Mr. Barnes provided an update to the Committee members on the status of the financial audits. The Local Partnership and Finance staff are working with the Local Partnerships to complete corrective action plans.

#### Local Partnership Benefit Issues

There have been some employee benefits issues that have been taking place in Florence. State Office staff have been working closely with the Executive Director of Florence County First Steps to ensure that the employees of Florence County First Steps received their pay and health insurance. These employees are losing their enrollment for retirement benefits due to actions taken by Florence School District #1. We are working with an attorney to help resolve the issues for the employees.

#### **4K Program**

The staff gave an update on the 4K Program.






In South Carolina, the population of children under age 6 for whom poverty status can be determined has been decreasing since 2012 (figure 1).


In South Carolina, the population of those under six who are <185% federal poverty level has been decreasing since 2013 (figure 2).

## Minutes from Finance and Administration Committee Meeting January 20, 2021

Members present: Walter Fleming, Chairman, Tim Holt, Dave Morley

Members not present: N/A

Nonmembers present: Mark Barnes, Director of Administration; Lavinia Tejada, CPA,

Zoom Video Meeting was called to order by Walter Fleming at 10:00 am.

Chairman Fleming greeted the group and brought the meeting to order.

#### Approval of the Local Partnership Allocation for SFY 2021-22

Mr. Barnes presented the proposed allocation amounts for the Local Partnerships for State Fiscal Year 2021-22. He reminded the committee of the new allocation model that was passed by the Board of Trustees two years ago. He shared the new year's model with updated demographics per the policy. He also mentioned the changes in the number of children 5 or under that are living in families with income less than 185% of poverty and talked about this being the third and final year of the phase in of the model. This year, the Local Partnerships will feel the impact of an additional 50% which will bring the total to 100% of the new allocation. The Committee had general discussion regarding the allocation model and amounts and the impact on the Local Partnerships. Tim Holtz motioned that the Committee approve the allocations as presented, with the Committee unanimously voting to approve the allocations and send them to the Board for Approval. Dave Morley thanked the Committee for their vision and hard work on revising and implementing the allocations model.

#### Approval of Match Waiver Requests by the Local Partnerships for SFY 2019-20

Mr. Barnes presented the two requests from the Local Partnerships for waivers of the required 15% match requirements. This included Kershaw and Horry County First Steps. He reminded them that these requests were for time during the Pandemic and the Program and Grants Committee had discussed and supported giving waivers based on the impact of the Pandemic on the Local Partnerships. Tim Holtz motioned the Committee approve the waivers for the two requests. The Committee voted unanimously voted to approve the waiver requests.

#### First Steps State Office

#### **COVID19 Situation Update**

Mr. Barnes presented an update to the Committee on the impact of the pandemic. Most staff continue to telecommute, and our work is continuing.

We are still working to get the COVID reimbursements that was approved. In addition to the \$4.2 million in federal COVID funds, we have also been awarded \$5 million in funds from the Governor's Office, which we are also waiting to receive. These funds will be used to cover the extended day and extended year cost for the 4K Program. (Update: The \$4.2 million in funds were received late in January)



#### **Financial Report**

The YTD financial report was reviewed by Mr. Barnes. The organization's financial position is strong, He noted that the total expenditures for 4K continue to be down for the year due to the Pandemic. At this point we continue to expect a cash balance in the Program at the end of the year, depending on enrollment between now and June 30.

#### Lease Update

Mr. Barnes updated the Committee on the current status of our Lease Solicitation process. We are still working with the appropriate state agencies to select and get approval for a new facility and will most likely be moving in the summer of this year.

#### **State Budget**

The Agency presented its State Budget Request to the House Ways and Means Subcommittee on Wednesday, January 13<sup>th</sup>. SC First Steps request has not changed since we submitted our request to the Governors Office. We requested an additional \$10.3 million in new funding. Our next steps will include presenting our request to the Senate. The Governors Office submitted a plan that would expand our 4K Program statewide which would be more funding for 4K than we requested if it passes.

#### **Local Partnerships**

#### Update on Raisers Edge

We are continuing to move forward with implementation of Blackbaud's Raiser's Edge, which is a fundraising system that was purchased along with their Financial Edge software. Finance staff is working with Betty Gardiner to implement the new system.

#### Local Partnership Financial Audit Update

Mr. Barnes provided an update to the Committee members on the status of the financial audits. The Local Partnership and Finance staff are working with the Local Partnerships to complete corrective action plans.

#### Local Partnership Benefit Issues

Mr. Barnes informed the Committee about the benefits issues that have been taking place in Florence. He has been working closely with the Executive Director to ensure that the employees of Florence County First Steps received their pay and health insurance. He mentioned they were losing their enrollment in retirement benefits due to actions taken by Florence School District #1. We are working with an attorney to help resolve the issues for the employees.

#### **4K Program**

Staff gave an update on the program's status.





#### RE: Report of the Local Partnership Program and Grants Committee

- 1. Informaton item: introduction of new committee member John Hayes John Hayes was introduced as the newest member of the SC First Steps Local Partnership Program and Grants Committee, filling the role previously held by Julie Hussey. John joins this committee with over 30 years of early childhood experience and currently serves as the Director of the Child Development Center at York Technical College.
- 2. Information item: Grant Making Update presented by Director of Grant Making and Development (attachment-Grants and ECI Presentation)
  Betty Gardiner, Director of Grantmaking and Development, presented on the current and previous grant opportunities that were offered to Local Partnerships including the previous Early Childhood innovation grant from 2018 as well as current grants such as AmeriCorps and the Family Services Expansion Grants provided through Preschool Development Grant funding.
- 3. Information item: Review of Program and Accountability Standards
  The committee was briefed that the evidence based program Ready 4K! would be added to the
  FY22 standards as well as three evidence-informed programs. The final standards are set to be
  approved by the Board in April.
- 4. Information item: Update on Corrective Action Plans
  The Corrective Action Plans were addressed and many of the findings have been resolved by the
  Local Partnerships and the only remaining steps are continued monitoring, especially for fiscal
  requirements. Horry County First Steps is still working to meet the minimum requirement of
  board members and Marion County First Steps is working through financial findings that include
  the submission of a time-study.
- 5. **Action item**: Early Childhood Innovation Grants Cycle 2 **Motion (part of the consent agenda):**

The Program and Grants Committee recommends that the First Steps Board of Trustees approve the "Early Childhood Innovation Grant Application and Process" (see attached application) for awarding competitive grant funding to eligible Local Partnerships.



The Program and Grants Committee thoroughly reviewed the ideas and changes related to the newest Early Childhood Innovation Grants process. Many of these ideas were derived from Local Partnership Executive Director feedback in conjunction with the ideas of staff and state board members. After much discussion on award limits, the timeline and length of the awards cycle, collaborative grants (multi-partnership application), as well as availability of funding – the committee decided to submit these ideas back to staff for implementation into a draft application. The committee reconvened at 1:00 PM on February 11, 2021. They were informed that \$250,000 in funds could be awarded from a combination of the following sources: recaptured funds, tax check-off funds, privately raised funds and EIA funds. After careful review of the proposed grant application, the committee recommend approval of the application to the State Board.

The committee was briefed that Ready 4K! would be added to the FY22 standards as a new evidence-based program. In addition, three evidence-informed programs will be added. Input from local partnerships regarding current standards is being received. The committee will review suggested changes at their April meeting. The final standards for FY22 are set to be approved by the Board in April.

5. Information item: Update on Local Partnership Corrective Action Plans

The Corrective Action Plans were addressed and many of the findings have been resolved by the Local Partnerships and the only remaining steps are continued monitoring, especially for fiscal requirements. Horry County First Steps is still working to meet the minimum requirement of board members and Marion County First Steps is working through financial findings that include the submission of a time-study.

As the only funder of early childhood programs in **every county** of the state, SC First Steps both administers **formula** grants of state funding to local First Steps partnerships on behalf of the General Assembly and actively seeks additional public and private resources to make **competitive** and **targeted** grants in support of services to children birth through five.

**Formula:** Funding allocated to each local partnership using the

state board-approved funding formula.

**Competitive:** All local partnerships are eligible to apply. Opportunity to

customize program focus, process based on state board

priorities.

**Targeted:** Eligibility to apply is based on program focus,

geography, or other criteria.

## Competitive and Targeted Grants: Why?

## Proposed Fiscal Guidelines for Discretionary and Targeted Grants

#### General

- Guidance on what legislative requirements for admin, core functions, and EB program percentages are required (state board has discretion for funding outside the formula allocation)

## Proposed Fiscal Guidelines for Discretionary and Targeted Grants

#### **Personnel Costs**

- Grant funds may be used to fund new program staff, or to increase the hours per week (up to 40, w/o overtime) of existing staff
- Grant funds may not be used to increase the compensation of existing staff. Such compensation increases must be paid for with other funding, and ED compensation increases must be approved by the partnership board.

### **Equipment/Renovation/Capital Projects**

- Certain grants (Innovation Grants) may consider capital projects on a case-by-case basis. Applicants must first schedule a meeting with the CFO and Chief Partnership Officer to discuss the project before submitting an application.
- Considerations include, but are not limited to: property ownership, demonstration of long-term occupancy and collaboration, and projected impact on program access and quality
- Such projects must be approved by the SC First Steps board

# Early Childhood Innovation Grant Competitive Grant Opportunity for First Steps Local Partnerships

#### 2021 Deadlines:

May 10: Program Officer consultation (optional)

June 14: submit notice of intent to apply (required), submit proposal draft (optional)

July 9 by 5:00 pm: submit final application (required)

#### Early Childhood Innovation (ECI) Grants:

The SC First Steps Board of Trustees intends to award competitive grants to local partnerships that incentivize and support measurable outcomes, leverage resources, and build capacity for improving program access and quality. The intent of the grants is to invest in innovative, collaborative efforts that benefit children 0-5, their caregivers, and their communities and support the strategic direction of the local partnership(s) and the overall First Steps initiative.

Up to \$250,000 will be awarded under the 2021 ECI Grant competition. Local partnerships may apply singularly, or as part of a multi-county application.

#### Minimum and maximum funding and duration:

The minimum grant award amount is \$5,000.00. There is no set maximum, but it is the intent of the SC First Steps Board of Trustees that this grant competition benefit several Local Partnerships. Therefore, requests for the full amount of available funding will not be considered. The state board reserves the right to offer partial funding to applicants in an effort to increase the number of awards made.

ECI Grants will be approved by the state board at the August 2021 board meeting and be available to local partnerships beginning September 1, 2021, contingent upon receipt of a signed amendment to their FY22 Local Partnership Grant Agreement. Partnerships may propose to spend ECI Grant funding over a period of one year (FY22), or two years (FY22 and FY23). NOTE: multi-year grantees must demonstrate satisfactory performance in Year 1 of their project in order to receive Year 2 funding. Year 2 funding is expected, but remains subject to availability, and Year 2 funding may be reduced if the partnership has available carryforward funding.

#### Allowable Uses of ECI Grant Funding:

ECI Grant funds may be used for a variety of purposes that support the partnership's Comprehensive Plan (https://scfirststeps.org/resources/reports/), including but not limited to program expansion, new programs or initiatives, core functions, or capacity building activities. Carefully consider other competitive and targeted funding opportunities offered by SC First Steps for FY22 when developing your application.

ECI Grants are subject to the following conditions:

#### General

- ECI Grant Funds will be coded as Fund XX in the partnership's Budget Spending Plan, and Project Code XX will be used when submitting payment requests.
- Unlike the Local Partnership's formula funding allocation, ECI Grant funding will not be included in percentage calculations used to assess compliance with restrictions for expenditures within Evidence-Based/Evidence-Informed programs, Core Functions, or Administrative Expenses.
- Because ECI Grant funding includes recaptured state funds, ECI Grants **cannot** be counted towards Local Partnerships' 15% match requirement.
- Matching funds are not required for this grant competition, but if applicable should be reflected in the proposed budget.
- ECI Grant funding must be expended by June 30, 2023. Unexpended grant funds after this date may be recaptured by SC First Steps.
- Multi-partnership applications are encouraged, but must name one local partnership to be the lead applicant.
- ECI-funded projects must comply with all applicable SC First Steps Program and Partnership Accountability Standards, including requirements for data collection within the First Steps Data Collection System.

#### **Shared Costs/Cost Allocation**

Applicants may propose a reasonable allocation of ECI Grant funds toward shared costs, taking into consideration:

- Whether the Local Partnership is the lead applicant or a participating partnership
- Whether the project includes creating a new program vs. expanding an existing program that is already cost allocated within the Partnership's budget
- Duration of the proposed program
- The number of other programs offered by the partnership
- No administrative or indirect percentage may be charged. Administrative costs must be included as line items in the application budget and described in detail.
- Grant scoring will consider the cost per client for similar programs and the overall costbenefit of the project to children, families, providers, and the community

#### **Personnel Costs**

- ECI Grant funds may be used to fund new program staff positions or increase the hours worked per week or scope of work (up to 40, w/o overtime) of existing staff.
- Grant funds may not be used to increase the compensation rates of existing supervisory staff. Such compensation increases must be paid for with other funding, and ED compensation increases must be approved by the partnership board.

#### **Equipment/Renovation/Capital Projects**

- Local Partnerships may apply to use ECI Grant funding for such projects on a case-bycase basis. Applicants must first schedule a meeting with the CFO and Chief Partnership Officer to discuss the project before submitting an application. Considerations include, but are not limited to property ownership, demonstration of long-term occupancy and collaboration, and projected impact on program access and quality.
- Such projects are subject to approval by the SC First Steps board, independent of reviewer scoring.

#### **Grant Eligibility Requirements:**

- 1. All Local Partnerships with no outstanding compliance issues are automatically eligible to apply. Those partnerships with outstanding compliance issues must either resolve those issues, or provide sufficient justification for any outstanding issues to the state board Program and Grants Committee by April 1, 2021. The Program and Grants Committee will provide to the full board for consideration at the April 2021 board meeting a list of any Local Partnerships recommended for funding disqualification. Disqualified Local Partnerships may not apply for an ECI Grant, receive ECI Grant funding, or participate as part of a multi-partnership application. Any subsequently disqualified Local Partnerships will be informed of this decision by the Chief Partnership Officer.
- 2. If proposal is for expansion of an existing program, applicants must justify the need for program expansion by waiting lists, new target areas or target populations, identified underserved groups, or other quantitative measures of unmet need.
- 3. Multiple local partnerships are encouraged to submit a joint application. If submitting a joint application, one Local Partnership must be designated as the lead applicant; the Project Description must describe the responsibilities of each participating partnership to the project; and the Budget must detail the proposed allocation of ECI Grant funding to each partnership.
- 4. If a Local Partnership submitting an application, or participating in a joint application, had carryforward in excess of 15% from FY20 to FY21, or expects to have excess carryforward from FY21 to FY22, the applicant must provide a justification of a) how excess carryforward is being, or will be, expended for other unmet needs; or b) how carryforward funding will be used to support the project. The state board reserves the right to amend (reduce) ECI Grant funding post-award, in the event one or more Local Partnerships has excess carryforward from FY21 to FY22 that was not accounted for in the awardee's grant application.
- 5. Private matching funds are not required.

#### **Application and Scoring Process:**

#### **Pre-Submission:**

It is **required** that Local Partnerships intending to apply for an ECI Grant send an email to their assigned Program Officer to that effect by **June 14, 2021**, listing (if applicable) all other Local Partnerships that will be included in the application.

It is **recommended**, but not required, that Local Partnerships schedule a meeting with their assigned SC First Steps Program Officer by **May 10, 2021** to discuss their project idea and receive feedback. Partnerships considering a multi-county application should schedule a collaborative meeting with all applicable EDs, Program Officers, and program staff as appropriate.

#### **MINUTES**

The meeting opened at 1:03 PM by welcoming new committee members, Jesica Mackey (Parent of a Young Child) and Janie Neeley (Parent of a Young Child), and a new staff person, Justina Siuba, who will serve as the Statewide Longitudinal Data System Project Coordinator.

The meeting was spent discussing the committee's thoughts on the long-term (K-12) outcomes and demographics for the South Carolina Early Learning Extension (SCELE) of the Statewide Longitudinal Data System. Justina Siuba will be facilitating the formation of the data governance committee for the SCELE, as well as convening advisory/focus groups of various stakeholders for input over the next several months.

For demographics, the committee discussed the differences between Individual Education and 504 Plans were discussed in depth, particularly around how to understand if they are meeting the child's needs. For long-term outcomes, there was a lot of discussion on informal assessments that may be a better measure of student progress than those that are more formal, especially through third grade. Further, there was great discussion about measures of college and career readiness, particularly around measuring the need for remedial education after high school.

Further discussion of these items, as well as what is of interest while the children are enrolled in the early care and education programs included in the SCELE (Head Start; Department of Social Services SC Voucher; CERDEP 4K (Department of Education and First Steps); First Steps Local Partnerships), will be ongoing for this committee.

The meeting adjourned at 2:12 PM.

#### What the Research Tells Us about 4K

- **S512 & H3858** Establishes that teachers and support staff (Senate "certified teachers" / House "K-12 teachers") would be included in **Phase 1a** of vaccine distribution plan. Introduced by Sen. Massey, Sen. Malloy, etc. and Rep. Ott, Rep. Collins, etc.
- H3079 Study Committee to Examine the Availability of High-Quality Childcare in the State and Recommend Policies to Support the Development of More Widely Accessible High-Quality Providers Throughout the State, Introduced by Rep. Collins and Rep. Cobb-Hunter
- **S11** Paid Family Leave for State Employees. Provides state employees 12 weeks of paid parental leave and would apply to those who give birth, adopt, or foster. Introduced by Sen. Darrell Jackson.

#### Grants

#### BlueCross BlueShield of South Carolina Foundation (due March 17)

Current funding supports an early identification and referral program within three local First Steps partnerships (Beaufort, Charleston, Lexington) targeting Latino families with children 0-5 in collaboration with PASOs. Seeking opportunities with BCBSSCF to extend/expand funding beyond the current grant, which ends May 31, 2021.

#### The Duke Endowment (due Feb.15) and the Doris Duke Charitable Foundation (due Feb. 26)

First Steps plans to submit a co-funding opportunity to TDE and the DDCF to expand evidence-based, intensive parenting services to 250 families with children 0-5 annually who are receiving Family Preservation Services within the child welfare system, in partnership with multiple local First Steps partnerships and Parents As Teachers affiliates, SCDSS, SCIMHA, SCDMH, and the National Office of Parents as Teachers.

#### Robert Wood Johnson Foundation (Letter of Intent due February 16)

SC First Steps is being included as a partner within a research proposal to the RWJF by Dr. Iheoma U. Iruka, Research Professor of Public Policy and Director of the Early Childhood Health and Racial Equity Program at the Frank Porter Graham Child Development Institute at the University of North Carolina – Chapel Hill. The proposal is to conduct a formative evaluation on the impact of infusing positive racial identity formation principles within the Parents as Teachers service delivery model, specifically as it relates to serving highly vulnerable families involved in the child welfare system.

#### Early Childhood Comprehensive Systems: Health Integration Prenatal-to-Three Program (due March 15)

This federal grant opportunity from the Health Resources and Services Administration (HRSA) will provide five years of funding at a maximum of \$255,600 per year to build integrated maternal and early childhood systems of care for the prenatal to 3-year-old population. We have submitted a proposal to SCDHEC describing how the activities of the Early Childhood Advisory Council can support a potential ECCS application from South Carolina, specifically in regards to grant



requirements for inter-agency collaboration, integration of health within the state's B-5 strategic plan, and support for family leadership and voice.

## Impact and Program Features of First Steps 4K: A Literature Review



In 2006, South Carolina began offering a full day 4K program for eligible children in certain parts of the state. South Carolina uses a mixed delivery system, with the program being offered in public schools, through the State Department of Education, and in private, nonprofit and faith-based childcare centers, through South Carolina First Steps.

#### What the Research Tells Us About 4K in South Carolina

Dr. Breyon Williams, an economist at the University of South Carolina, conducted a quantitative study investigating the average impact of living in a CERDEP district at age 4 and being eligible for the program on outcomes in 3<sup>rd</sup> through 5<sup>th</sup> grade<sup>1</sup>. This study was published in a peer-reviewed journal, *Economics of Education Review*, in 2019.

#### His research found:

- Children who were exposed to and eligible for South Carolina's full day 4K program (CERDEP) had significantly higher math and reading scores and lower disciplinary actions, on average, in grades three through five than those not exposed and those not eligible.
- In CERDEP districts, a positive spillover effect benefiting other children, who were not
  eligible for the program but were in classrooms in later grades with children who were,
  was observed. These children had significantly higher math and reading scores, on
  average, in grades three through five.
- The impact was dramatic. Children who lived in a CERDEP district and were eligible for the program had, on average, math scores that were 18.6% higher and reading scores that were 18.4% higher than children who did not live in a CERDEP district and were not eligible for the program.

Across the country, studies show that children who attended a state-funded pre-K program had significantly higher levels of language and math skills in kindergarten, compared to those who did not have that experience<sup>2–5</sup>.


## First Steps 4K uses evidence-based curricula in approved, high-quality childcare centers and school settings.

Although the Montessori Method and High/Scope are supported, the large majority of our 4K programs implement Creative Curriculum® by Teaching Strategies. Creative Curriculum® is a developmentally appropriate, whole-child approach that is academically rigorous, aligned to South Carolina's Early Learning Standards<sup>6</sup>, and promotes social-emotional development<sup>7,8</sup>. All First Steps 4K students are assessed with GOLD® by Teaching Strategies, a birth through third grade tool. GOLD® is an observation-based formative assessment that supports differentiated





effective instruction. Authentic performance and progress ratings guide the learning plan for each student. Students are assessed three times throughout a traditional school year.

First Steps 4K employs Conscious Discipline, an evidence-based program to support social-emotional growth. Use of this curriculum is significantly associated with improved child-teacher interaction and children's social-emotional skills and executive functioning<sup>9</sup>. The majority (85%) of First Steps 4K centers participate in the ABC Quality Rating System, and 72% of those are rated B or higher. First Steps 4K centers receive a materials grant worth \$10,000 to furnish their 4K classrooms with materials to support rich instructional environments.

## First Steps 4K teachers are highly qualified and supported by ongoing professional development and intense coaching.

Teachers in First Steps 4K classrooms are formally trained in early childhood development and are required to have at least an associate degree and be enrolled to complete a four-year degree within four years. A recent study showed no significant differences in child outcomes in the 4K year between classrooms where not all teachers had a four-year degree and those where all teachers had a four-year degree <sup>10</sup>. First Steps 4K has a team of 12 high-level coaches located throughout the state, who visit centers at least bi-weekly and provide ongoing technical assistance, coaching and mentoring, and professional development for teachers and directors. Right now, classroom visits take place virtually, but in-person visits will resume as soon as it is deemed safe. Annually, three large professional development events are hosted by our First Steps 4K team, Teacher and Director Academies and Palmetto Pre-K Jamboree.

#### Impact and Program Features of First Steps 4K: A Literature Review



#### First Steps 4K meets families where they are.

First Steps 4K takes place in a variety of settings from private childcare centers, faith-based centers, federal military centers, and charter schools throughout the state. First Steps 4K classrooms have the option to offer traditional (6.5 hours/day) or extended (8 hours/day) day and traditional (180 days) or extended (220 days) year options to families. Starting in summer 2021, rising four-year olds will be permitted to enroll, provided their 4<sup>th</sup> birthday is on or before September 1, the summer before they would be typically enrolled in a 4K classroom. This will enable some children to be served in a First Steps 4K classroom for close to 18 months!

Other program features include transportation and an accessible application process. Providers who provide transportation to their families receive an increased reimbursement rate. PalmettoPreK.org and Free4KSC.org are portals for families to learn about what they qualify for and what is available near them. We also run targeted marketing efforts throughout the year statewide to recruit families and providers. The entire application process for families is available online, and students can enroll on an ongoing basis throughout the school year.

We are adding new First Steps 4K classrooms every day, and we are excited to expand this program to serve more eligible students throughout the state!

### First Steps All-Team Survey Full Report | January 2021

#### **Overview**

The First Steps Team Survey was administered December 9-10, 2020 and had 54 respondents (98% response rate). Most respondents reported being at the agency less than five years (78%). The racial/ethnic distribution of respondents was: 62% white; 31% Black; 4% multiple ethnicities or other; 2% Hispanic; 2% American Indian or Alaska Native. The team distribution of respondents was: 40% 4K; 25% Capacity Building; 19% Local Partnerships; 15% Finance and Administration. The Capacity Building team includes the Communications, Grant Making and Development, Early Childhood Advisory Council, and Strategic Impact teams.






#### **Diversity, Equity, and Inclusion**

More than half 'strongly agreed' that support is provided fairly and equitably on their team and that First Steps' environment is family-friendly, inclusive, and supportive of continuous learning, growth, and development. Almost two-thirds 'strongly disagreed' that they have considered leaving First Steps because they felt isolated or unwelcomed. Over one-third 'strongly disagreed' that they feel others do not value their opinion at First Steps.




#### **Professional Development**

Half of respondents 'strongly agreed' that they receive adequate feedback on performance and their experience at First Steps has had a positive influence on their professional growth. 






#### **Team Dynamics**
